DEFENDANT IN COURT WITH COUNSEL GREGORY ROBEY. PROSECUTING ATTORNEY MEL PLANAS PRESENT. DEFENDANT WAS ADVISED OF ALL CONSTITUTIONAL RIGHTS AND PENALTIES. ON RECOMMENDATION OF THE PROSECUTOR COUNTS 8, 9, 10, 11, 12 AND 13 ARE AMENDED BY ADDING ATTEMPT.

DEFENDANT RETRACTS FORMER PLEA OF NOT GUILTY AND ENTERS A PLEA OF GUILTY TO TAMPERING WITH RECORDS RC 2913.42 M-1 SB2 AS CHARGED IN COUNTS 2, 3, 4, 5, 6 AND 7; ATTEMPT FORGERY RC 2923.02/2913.31 M-1 AS AMENDED IN COUNTS 8, 9, 10, 11, 12 AND 13.

COURT FINDS DEFENDANT GUILTY. REMAINING COUNTS ARE NOLLED.

IT IS THEREFORE ORDERED AND ADJUDGED THAT THE DEFENDANT IS SENTENCED TO THE CUYAHOGA COUNTY JAIL FOR A TERM OF 6 MONTHS ON EACH COUNT, COUNTS TO RUN CONCURRENT WITH EACH OTHER. DEFENDANT TO PAY COURT COSTS.

SENTENCE IS SUSPENDED. DEFENDANT TO SURRENDER HER STATE BOARD OF SPEECH, LANGUAGE PATHOLOGY AND AUDIOLOGY LICENSE AND HAVE NO CONTACT WITH THE WARRENSVILLE DEVELOPMENTAL CENTER.

DEFENDANT TO PAY \$1,292.03 RESTITUTION TODAY THROUGH THE PROBATION DEPARTMENT. DEFENDANT TO PAY COURT COSTS WITHIN 6 MONTHS.
