### ADJUDICATION ORDER

The hearing in this matter was held before Hearing Officer Paul Stehura on August 26, 2002. The Hearing Officer issued the Report and Recommendation (hereinafter "Report") on September 4, 2002. By letter dated September 5, 2002, the Report was mailed to Ms. Bates by certified mail, and to her attorney, with information on her ability to file objections within ten (10) days of receipt of the Report. Ms. Bates filed objections to the Report on October 7, 2002. Assistant Attorney General Barbara Petrella filed a Response to Objections on October 15, 2002.

At its November 6, 2002 meeting, the Board considered and deliberated on the matter. Present at the meeting were: Jane Kukula, Au.D., Chair; Ann Shotwell, Public Member; Ann Glaser, M.S.; Judith Harvey, Ph.D., Public Member; Carol Leslie, Ph.D.; Pat Mangino, M.A.; Cindy Satterfield, M.A.; and Debra Abel, Au.D. All of the members affirmed that they had received, read, and considered the Report, the Objections, the Response to the Objections, and all documents included in the record.

Upon consideration of the hearing record, the Report, the Objections, and the Response to Objections, the Board, by unanimous vote, took the following action:

The Board accepted the Findings of Fact, Conclusions of Law, and Recommendation of the Hearing Examiner.

**Therefore, it is hereby ORDERED** by the Ohio Board of Speech-Language Pathology and Audiology that the application of Cleopatra Bates to be licensed as a speech-language pathologist be **denied**. This Adjudication Order shall become effective immediately upon receipt.

### APPEAL RIGHTS

This Order may be appealed pursuant to Section 119.12, Ohio Revised Code, **by filing the original Notice of Appeal with the Ohio Board of Speech-Language Pathology and Audiology**, 77 South High Street, 16<sup>th</sup> Floor, Columbus, Ohio 43215, and a **copy of said Notice of Appeal with the proper court of common pleas** as determined under


Section 119.12, Ohio Revised Code. Such Notice of Appeal shall contain the Order appealed from and the grounds of said appeal. Such original Notice of Appeal must be filed at the Board office and the copy of said Notice of Appeal filed at the proper court of common pleas **within fifteen** (15) calendar days of the mailing date of this Order.
